SPA Members present: Erika Aust, Dr. Lawanda Dockin, Charlie Endicott, Seth Endicott, Vice President Dane Foust (opening remarks), Khadijah Greene, Candace Henry, Belinda Poole, Dr. Wallace Southerland, Blossom Thao, and Sarah Winger (special guest)

1. Dr. Southerland opened the meeting at 9:01 a.m.
2. Dr. Southerland asked each member to introduce themselves and share why they joined the committee or allowed themselves to be drafted. He acknowledged whether drafted or volunteered, we are all on one team.
3. Vice President Foust thanked all for attending
 - a. Assessment is important in Student Affairs, to look at functions within each area and discern what is working well and what should be changed.
 - b. Dr. Foust highlighted his primary concern. The committee will be tasked with providing feedback on a student survey assessing students' needs, concerns, and plans for Spring 2021, which should help with adjusting to the COVID environment and beyond.
 - c. Secondly, it is important to continue to develop a comprehensive assessment to capture the work done in Student Affairs.
 - d. Dr. Foust visits other schools for middle states assessment and is always looking for data to reflect what they do. He is asking the group to recommend strategies for improving division-wide assessment and accountability, to aid in compiling the data for our future assessments.
 - e. Dr. Foust reminded the group of the importance of sharing their expertise, acknowledging that some departments do well and others are still developing.
 - f. He appreciates all of the efforts of the committee.
4. Dr. Southerland introduced special guest Sarah Winger, Assessment Coordinator and FOSA (Friend of Student Affairs). She coordinates campus-wide efforts to spotlight SU nationally using various feedback. Sarah is excited to collaborate with SPA to integrate SA with campus data.
5. Dr. Southerland reminded the committee of the accreditation dates and how universities are accredited by regional associations. The data are used to improve the student experience. Sarah mentioned that generally there have been a lot of shifts involved in the review, fewer sections. Accreditation includes everything from student learning outcomes to leadership and budget, to determine how we are doing as an institution. Dates:

- 47 6. Dr. Southerland introduced next presenter and committee member, Dr. Lawanda DeMills
- 48 Lawanda thanked Dr. Southerland for his leadership and everyone for their efforts in sharing a
- 49 document of the divisionwide SWOT analysis. A SWOT was conducted on every department
- 50 within Student Affairs, in six phases. The committee talked to each department, gathering goals for
- 51 each unit, which have been compiled for the division. The executive summary outlines the actions
- 52 taken by the committee, the timeline, as well as an inspirational video by Dr. Foust to indicate the
- 53 significance of the process.

- 55 The SWOT analysis was conducted throughout July and August, compiled and returned to the
